

3 ESG Sentinel: The Basics

3.1 Navigating the Platform

From the ESG Sentinel platform, you can explore different features, adjust your settings, set up alerts, and search for companies. Here's a quick guide to where everything is on ESG Sentinel and how to make sense of it.



3.2 ESG Scoring

At the heart of ESG Sentinel lies its scoring system. The platform is powered by a proprietary AI algorithm which analyzes millions of online articles, NGO reports, and social media sources to assign three types of scores to your ESG risk intelligence. These include:

1. **Risk Score:** Measures how much potential damage an ESG issue could cause.
2. **Severity Score:** Evaluates how serious an incident is.
3. **Credibility Score:** Determines how reliable incident source material is.

Risk Scores and **Severity Scores** are color-coded and rated out of 100, making it easy to grasp how serious an ESG issue might be, and all three scores are updated constantly; based on real-time data.




3.2.1 Risk Scores

ESG Sentinel's **Risk Score** helps you understand how much of a threat an ESG issue might pose to a company's performance, stability, and reputation.

- 🔴 **High:** Requires immediate attention and strategic action.
- 🟡 **Medium:** Should be actively managed to prevent escalation.
- 🟢 **Low:** A low-risk situation, but still worth monitoring.
- 🟢 **Secure:** Minimal ESG risk. No immediate concerns.

When an ESG Risk Score changes, you'll see a color-coded percentage indicator showing whether the risk is rising or falling.



Customizing ESG Risk Scores

ESG Sentinel automatically assigns risk scores by default. However, you can customize how these scores are decided for specific companies and industries, or across the entire platform.

To start customizing your risk scores, click the **Customize Risk Score** button in the top-right of your [Portfolio Page](#). This brings you to the Risk Score Customization Page.

At the top of this page is your customized risk score (if already customized) and Syenah's default score; generated by ESG Sentinel.



From this page, you can customize how ESG Sentinel assigns risk scores across the platform. Choose between:

- **Risk Score Weight:** Customize how risk scores are weighted for specific industries and companies, including your own, based on ESG categories.
- **Incident Risk Criteria:** Modify the criteria that ESG Sentinel uses to assess a company's risk level.

Use the tabs at the top of the page to switch between these options.

Risk Score Weight Customization

This option lets you set default risk score weightings across the entire ESG Sentinel platform, or customize them for specific companies and industries.

Each option here takes you to the risk customization panel, where you can tweak the parameters of the risk score based on specific ESG categories.

Customizing Default Risk Score

Your default risk score applies to all companies and industries on ESG Sentinel; except those that have already been customized.




Customizing Industry Risk Score

Your industry risk score weight applies to all companies within that industry (except companies that you've separately customized).




To customize the ESG risk scores for specific companies, click the **Add Company** button.




Editing your Customizations

Once you've customized the risk score for a company, industry, or supply chain tier, a link will appear in your settings.




Click on the vertical three-dot menu in the top right of this link to:

- **Delete** your customization (and restore the risk score to its default settings).



If you choose to delete your customization, you'll be asked to confirm your choice.



Click **Remove** to continue, or **Cancel** to exit without removing your customization.


Risk Score Customization Panel

You'll land on this page every time you want to customize your default risk score, or the risk score for specific companies and industries. From here, you can adjust the weighting of risk scores based on the ESG categories and subcategories you want to prioritize.




ESG category weights determine how overall risk scores are calculated.

As you adjust these weightings, certain ESG categories and subcategories will have more or less influence on the final score. This is shown by the pie chart (left), which updates to reflect your new weightings as you go.




You can adjust all ESG categories on this panel by dragging the scales. These range from 0 to 10, with 10 being the most sensitive weighting.


On this panel, you can adjust the three main ESG categories: **Environment, Social, and Governance**:




And adjust **ESG subcategories** within each main category:



When you're happy with your new risk score weights, click **Apply** in the bottom-right of the page. Click **Cancel** to exit the screen without saving.



You'll be asked to confirm your decision. Click **Agree, Proceed** to continue or **Let Me Review** to go back and double check your new weights before continuing.





How to Spot a Customized Risk Score

If you've customized a risk score, it will be marked by a cog symbol on the ESG Sentinel platform.



Incident Risk Criteria Weight

Rather than [changing risk scores directly](#), you can customize how ESG Sentinel evaluates *risk levels* on this page.

Be warned, though – adjusting incident risk criteria can result in a significant change to your overall risk scores across the platform.

Incident Risk Criteria Weights

In this section, you can manage your Risk Score assessment by assigning weights to five key variables that determine a company's risk level. The variables are Average Incident Severity, Social Network Perception, News Agency Articles & NGO Reports, and Social Media Posts.

You can assign points from 0 to 10 to each variable, indicating their relative importance in your assessment. Drag the slider to assign the desired weight to each variable and create a personalized Risk Score assessment that aligns with your priorities and values.



Customizing Incident Risk Criteria

Incident Risk Criteria on ESG Sentinel are broken down into four categories:

- **Incident Severity**
- **News Agency & NGO Coverage**
- **Social Network Perception**
- **Social Media Coverage**

Each factor has a **sensitivity slider (0-10)**. Higher values mean a greater influence on final risk scores. Move the sliders to select your preferences for each criteria.



Click **Save Changes** in the top right of the screen to save your customized incident risk criteria.



3.2.2 Severity Scores

The **Severity Score** measures the potential impact of an ESG incident; whether it's a minor issue or a major crisis.

Higher severity scores indicate more serious risks, such as regulatory violations, environmental disasters, or major governance failures. Lower scores apply to less critical incidents, like minor policy infractions or reputational concerns.

Severity Score Levels

 Critical  High  Moderate  Minor

Minor: Low impact, minimal disruption.

Moderate: Needs monitoring to prevent escalation.

High: Significant risk—action required.

Critical: Severe crisis with major consequences.

How are Severity Scores Calculated?

ESG Sentinel calculates an overall Severity score from two other scores: **Severity Impact** and **ESG Category**.

The **Severity Impact** score is based on **seven factors** of an ESG incident:

- 1. Reputational Impact:** How much the incident affected a company's reputation.
- 2. Incident Scale:** How far-reaching the incident was in terms of geography, industry, or population affected.
- 3. Impact Duration:** How long the incident continued to affect the company or stakeholders.
- 4. Legal Consequences:** Whether the incident led to legal action, regulatory fines, or compliance violations.
- 5. Company Responsibility:** The degree of responsibility the company holds for the incident. If the company is directly at fault, the severity score increases as it shows a failure in internal processes, governance, or oversight.
- 6. Financial Impact:** The financial cost of the incident, including damages, fines, or loss of business.
- 7. Health and Safety:** The impact on health and safety, such as harm to employees, consumers, or the general public.


The **ESG Category** score breaks down the incident's impact by each ESG category (environmental, social, and governance), and even further by many sub-categories within each. To give you an idea, these categories can include:

- **Environmental impact** (i.e., climate change, pollution, resource depletion).
- **Social impact** (i.e., labor rights, community impact, human rights)
- **Governance impact** (i.e., regulatory compliance, diversity, ethical business practices).

ESG Sentinel uses both of these scores and their deciding factors to create an overall severity score for ESG incidents.

3.2.3 Credibility Scores

ESG Sentinel's **Credibility Score** measures the reliability of the sources reporting an ESG incident. This helps you assess whether the incidents you're tracking are legitimate, significant, and relevant.



The **Credibility Score** is categorized as follows:

Limited: The incident is mentioned by few sources, with little public discussion. It may be isolated, and the information may be unverified or unclear.

Average: The incident has gained some traction and is being discussed by several sources. However, there may still be questions around its full impact or legitimacy.

Trending: The incident is being covered by multiple media outlets, and it's starting to gain attention across social platforms. The incident is growing in visibility but may not yet be widely recognized globally.

Viral: The incident has widespread public attention and is being shared rapidly across multiple platforms. Coverage includes major news sources, and the discussion is gaining momentum across multiple regions and sectors.

Major: The incident is highly credible, with extensive and continuous coverage from top-tier sources, NGOs, and social media. It has significant implications, potentially affecting multiple industries or regions. This level often signals a large-scale crisis.

The most credible incidents are typically backed by many news outlets, have high [severity scores](#), involve multiple countries, feature NGO involvement, and have strong social media engagement.

3.3 Regulations

Staying compliant is easier said than done for many businesses. Regulations are growing stricter year after year, and many now require companies to actively identify, prevent, and report on a wide range of issues; not just within their own operations, but across their supply chains as well. Those who fail to stay diligent risk facing hefty fines and penalties.

ESG Sentinel helps you track non-compliance risks emerging from your investments. The platform provides clear insights on which regulations are being violated, how frequently, the severity of each breach, and any resulting fines or legal actions.





















9 Graph Exploration


The **Graph Exploration** feature makes it easy to see how companies in a supply chain are connected. Displayed like a web, the graph traces relationships, transactions, incidents, and regulatory breaches between different companies in the chain; even at its farthest edges.

This feature lets you trace pathways between supply chain companies, identify high-risk suppliers, and see where ESG risks are emerging from. It ultimately lets you see how the actions of a company's suppliers, customers, and partners (for better or worse) may ripple through the supply chain and affect your investments.

9.1 Creating a Graph

When you first open **Graph Exploration**, your graph will be empty.

Use the search bar in the center of the screen to find a company. It will be the focal point of your graph, with its supply chain branching out from there.




Start typing the company name and select the right option once it appears, then click the + symbol.



The company you select is marked by a check mark.

Your main company will appear in the center of the graph, and the search bar will disappear.



9.2 Reading the Graph

It pulls data from across the ESG Sentinel and presents its responses in formats you're already familiar with on the platform, including detailed charts and source cards that link to specific news reports and incident briefs.




10.2 Starting a New Chat

On the main screen of **ESG-GPT**, you'll see a prompt window where you can type your questions for the model.



If it's your first time using ESG-GPT, you won't have any saved chats yet, so simply type your question to start your first one.

If you've used ESG-GPT before and want to ask something new, click the **New Chat** button in the left-hand menu.



Type your question into the prompt field. You can ask ESG-GPT anything you're curious about when it comes to ESG performance and risk intelligence.



Here are some **best practices** for prompting the ESG-GPT model:

Write clear instructions	Be specific about what you want from ESG-GPT's response – whether that's the type of data, the length of response, or even the tone of voice.	<i>"Provide a summary of the main ESG risks in the automotive industry. Include a bar chart to show this."</i>
Include plenty of details	The more detailed your question, the better the response. Provide context to your questions to make sure ESG-GPT understands what you need and why.	<i>"Analyze ESG incidents in the retail sector over the past five years, focusing on labor violations. I need this for a risk trends report."</i>
Provide references	If you want the response to be based on specific reports, sources, or data, mention them in your prompt.	<i>"Tell me about ESG risks in the mining industry based on the latest NGO reports."</i>
Split up your question	If your question is complex or requires a specific format, break it down into steps or add constraints.	<i>"List the top 5 ESG risks in the energy sector, then explain how each affects financial performance. Don't include any data before 2020."</i>
Ask the model to adopt a persona	ESG-GPT can tailor its response based on the role you assign it.	<i>"Act as an ESG consultant and provide recommendations for improving a company's ESG risk score."</i>

You can't click the **Enter** button (upwards arrow) until you've typed something into the prompt field. Once you start typing, the button will turn blue. This means that ESG-GPT is ready to receive your question. Click it to send your query.

After you send your first query, the prompt field will change to say **Explore further**. You can enter follow-up questions here to narrow down on specific details or continue the conversation with ESG-GPT.



10.2.1 Local and Global Searches

ESG-GPT offers two search modes to help ensure it answers your question in the right context, with the appropriate data:

- **Local:** ESG-GPT provides detailed information about a specific company or event.
- **Global:** ESG-GPT offers a wider view of ESG trends from across the globe.



If you want to use one of these search modes, click on either **Local (Entity-Based Search)** or **Global (Thematic Search)** before sending your prompt and ESG-GPT will adjust its response accordingly.


10.2.2 Editing Queries

Instead of typing a new question for ESG-GPT, you might find it easier to edit your original query. This is especially useful if you just need to adjust the wording or add some extra details without generating a completely new response.


To do this, hover over your question title in the chat until you see the **Copy** and **Edit** buttons.



Click **Edit** to modify your question. Once you're done making changes, click **Save** to update it. If you decide not to make any changes, just hit **Cancel** to exit without saving.



Click **Copy** to copy your question text to your clipboard, so you can paste it elsewhere. A check mark will appear to confirm the action.




The edit counter below your question shows how many times you've edited it. Click the arrows to toggle between different versions.



10.3 Reading ESG-GPT's Output

Depending on the detail and complexity of your question, ESG-GPT's response may include a mix of text, charts, data, and source material.

Note: Sometimes, LLMs can generate inaccurate or misleading information, so it's always good to verify key details.

Text	ESG-GPT presents information clearly with headings, paragraphs, bullet points, and more. If the output feels too complex, you can ask it to simplify or restructure its response. 


10.4 Managing your Chats



All your recent chats with ESG-GPT are listed on the left-hand menu. You can click on any chat to continue the conversation.




10.4.2 Chat Library

Your **Chat Library** is where all your past chats are saved. You can access them to view, edit, or add them to a **Workspace**.


To open your Chat Library, click the **Chat Library** tab on the left side of the main ESG-GPT page.



In your Chat Library, each chat shows:




1. Your first question and a preview of ESG-GPT's response, as well as the date the chat was started (bottom right).
2. A Workspace label (if you've added the chat to a Workspace). Click on this label to open your [Workspaces](#) page.
3. An options menu:



- a. Click **Add to Workspace** to add your chat to your Workspaces.

This opens a menu where you can choose which Workspace to add the chat to.




- Click **Add** on the Workspace you want.




Click on the send arrow button to ask it to ESG-GPT. This will create a new chat page, and your current chat page will be added to your [Recent Chats](#) menu.


10.4.3 Renaming Chats

Hover over a chat to reveal a menu of options (three dots), click to open, and choose **Rename**.




Type in a new name and click **Save** to update it. To cancel, click **Cancel** or the **X** in the top-right corner of the box.




10.4.4 Deleting Chats

To delete a chat, hover over it, open the menu (three dots), and select **Delete Chat**.



You'll be asked to confirm your decision. Click **Delete** to delete your chat.


Click **Cancel** or the top-right **X** button to exit the screen without deleting.



10.5 Workspaces

Workspaces give you a focused space to ask ESG-GPT questions about certain topics or goals. By providing instructions for ESG-GPT on how to treat your conversations and uploading sources for context, you can tailor each Workspace to get the exact insights you need from ESG-GPT; all stored in one place and neatly organized for easy access later.

You can open your **Workspaces** from the left-hand column of the ESG-GPT feature.



10.5.1 Creating a Workspace

If it's your first time here, the Workspaces page will be empty.

Click **Create a Workspace** to get started. This opens the Workspace creation screen.



Create a Workspace to save and revisit conversations. Workspaces help manage insights and track discussions.


